### **Matters arising**

Cllr Daniel Richardson requested terms of reference for the group to be circulated.

### **Accelerated Funding**

Lydia introduced the papers provided highlighting the requirements of the fund.

Clarity was requested on what exactly accelerated funds were and where the money was coming from. The meeting was reminded that we are being encouraged to support the Towns Fund in responding to immediate challenges:

- Improvements to or new parks and green spaces and sustainable transport links.
- Improvements to town centres including repurposing empty commercial properties.
- Demolition or site remediation where this will have an immediate benefit.

Jon Burgess was welcomed to the meeting to present on the Sutton on Sea Colonnade.

General questions about the scheme were asked and answered; these questions were;

- What is the operating model for the Colonnade?
- Will there be links to other areas via cycling and walking links?
- Are we aligned to the working of the GLEP with reference to cycling and walking?
- A question surrounding the ice cream serving hatch.
- A question on the demolition and rebuild programme.
- Are the stairwell and kitchen positioned correctly?
- A question around the swimming pool and pleasure gardens.

Following on from discussion a vote was taken and it was unanimously agreed that the Sutton on Sea Colonnade goes forward for the accelerated funding.

### **Town Investment Plan**

Lydia introduced the topic and the papers and explained that our submission date for Town Investment Plan for Mablethorpe is 31<sup>st</sup> October.

Chairs of the PRG's and of the Connected Coast Board would welcome another meeting towards the mid to late August.
